I hope you enjoy this Q3 2024 Newsletter.














STAFF REFLECTIONS ON HURRICANE IVAN - 20TH ANNIVERSARY

YOUR EXPERIENCE

Following the 20th anniversary of Hurricane Ivan on September 11, 2024, we asked current staff who were on the island during the storm to provide comments on their experience 20 years ago.

"We were isolated for about 36 hours. We had ceiling damage but no flooding. Some trees blocked our driveway. It took three days for a neighbour with a chainsaw to clear the driveway. We had no power for almost 60 days. We had to repair the roof, which took over a year."

"My most significant memory of Ivan was going outside on the patio during the eye of the storm (from one of the highest points in Grand Cayman) and seeing the entire island and the surrounding ocean completely bracketed by the storm walls. Although it was eerily calm during the eye, the wind was still strong enough to slide me effortlessly across the patio. I'll never forget the completely calm and clear skies above us, surrounded by a perfect circle of menacing black storm clouds further than the eye could see. Seeing George Town below completely flooded yet knowing we were only halfway through the storm was a sobering thought."



Bonaventure Children's Home

FRESH START FOR BONAVENTURE CHILDREN'S HOME AFTER RENOVATION

(CAYMAN COMPASS - MAY 16, 2024)

Arch & Godfrey donated project and construction management services to the CAYS Foundation for the new multi-purpose residential unit, in collaboration with Michelle Butler, interior designer. Special thanks to Shawn Maxwell for taking the lead on this project, which resulted in a high-quality final product with exceptional workmanship.

A newly remodelled Bonaventure Children's Home was inaugurated in early May in West Bay by private donors, volunteers and government officials.

The multi-purpose residential unit, accessible by wheelchair, will serve children in need of secure and nurturing care.

The remodelled facility, operated by the CAYS Foundation, received \$100,000 in seed funding last year for the updates from the Ministry of Investment, Innovation and Social Development. Additional financial assistance and volunteer support came from the private sector to complete the project.

The CAYS Foundation provides traumainformed, therapeutic care for up to 34 young people across three facilities, the Bonaventure and Frances Bodden children's homes and Phoenix House.

"The CAYS Foundation is eternally grateful to our community partners who have made this project a reality through their donations of time, expertise and materials," said CAYS General Manager Keith Boyle in a public statement.

Acting Premier André Ebanks said the upgraded facility is part of a longterm vision from the foundation to overcome current challenges.
